

# Warranty

## Manufacturer's Limited Warranty

Cerka Industries warrants that its product to the original purchaser will be free of defect(s) for a period of three (3) years, providing that the following conditions are met and satisfied.

## Warranty Covers

This three (3) year warranty covers the frame, ramps, cross members, railing and sub-frame only. Wiring, lights and the main axle beam are warranted for one (1) year. Normal wear items will not be replaced due to wear. These normal wear items include but are not limited to flooring, galvanizing, brake lining(s), spring bushings and bearings. All auxiliary parts such as brakes, callipers, jacks, wheels, bearings, tires, and lights are covered by the warranty of their manufacturer.

## Limitations

The sole responsibility of Cerka Industries Ltd. under this limited warranty shall be to repair and/or replace parts at the Cerka Industries Ltd. factory or another location with prior written approval by Cerka Industries Ltd. All other obligations or liabilities, including incidental or consequential damages or contingent liabilities arising out of the failure of any parts to operate properly are hereby excluded, including but not limited to any damages resulting from loss of use, inconvenience, loss of time, commercial loss, or any other type of damages general or specific, foreseen or unforeseen. Cerka Industries Ltd. will not reimburse any claimant for any adjustment or repair without prior written approval from Cerka Industries Ltd.

Transportation Costs of any trailer to and/or from your dealer, or an approved repair facility, or Cerka Industries Ltd. shall be the responsibility of the trailer owner. Cerka Industries Ltd. shall not be held responsible for any such costs.

## Warranty Void

Cerka Industries Ltd. is not responsible for damage caused by accident, negligence, abuse, misapplication, lack of maintenance, or misuse of a trailer or any of its component parts. Loading in excess of gross vehicle weight rating (GVWR) stated on the VIN sticker will invalidate any and all warranties. Any modifications, alterations, or repair to any product manufactured by Cerka Industries Ltd. without Cerka Industries Ltd. prior knowledge and written consent will void manufacturer's warranty.

Trailers whether as to merchantability, fitness for a particular purpose or any other matter. ## Claims

Within ten (10) days after discovering a problem with your Cerka Trailer, return your trailer to Cerka Industries Ltd. or the dealer where you purchased the trailer.

Any defective parts must be sent by prepaid freight to Cerka Industries Ltd., in order to qualify for replacement or reimbursement under this limited warranty.

Cerka Industries Ltd. reserves the right to not pay unreasonable cost for replacement or repair of defects to a Cerka Industries Ltd. trailer, and may at its discretion, establish reasonable reimbursement or parts for any authorized work performed under the terms of this Limited Warranty.
